- 4. One time EOAA granted to the institute shall be revised /withdrawn on the verification of the non-fulfillment of any mandatory requirements as laid down by AICTE/COA/BTU. The same will also applicable on the verification of any serious complaint against the institute,
- 5. The EOAA shall be amended as per the approved course(s), with their intakes, for the engineering program as per the Extension of Approval (EOA) of AICTE for the respective academic session.
- 6. The EOAA will be immediately withdrawn on the closure of engineering program/institute by AICTE and also on the non-submission of AICTE extension of Approval (EOA) before the expiry of the granted one time EOAA.
